- THE PROPRIETOR IS NOT RESPONSIBLE FOR LOSS OF OR DAMAGE TO THE PROPERTY OF ANY VISITOR BROUGHT UPON THE PREMISES, WHETHER ARISING FROM THEFT, FIRE OR OTHERWISE, BY WHOMSOEVER CAUSED, OR ARISING FROM THE NEGLIGENCE OR WRONGFUL ACT OF ANY PERSON IN THE EMPLOY OF THE PROPRIETOR.
- MONEY OR VALUABLES MAY BE HANDED TO THE PROPRIETOR PERSONALLY FOR CUSTODY, WHERE A SPECIAL RECEIPT WILL BE ISSUED ACCORDINGLY.
- **DO NOT LITTER! NO DRINKING OR EATING IN THE SWIMMINGPOOL!**
- **IF YOU BREAK ANYTHING THAT IS PROPERTY OF OMBO REST CAMP, PLEASE REPORT TO THE STAFF OR MANAGER!**

- IF OVERNIGHT/FUNCTIONS AT THE RESTAURANT WOULD BE CANCELLED, **ONLY 20 % OF DEPOSIT WOULD BE REFUNDABLE.**
- IF OVERNIGHTS/FUNCTIONS AT THE RESTAURANT WOULD BE CANCELLED **48 HOURS BEFORE ARRIVAL 30 % OF THE DEPOSIT IS NOT REFUNDABLE.**
- ON ARRIVAL/BOOKING DATE, IF BOOKING IS CANCELLED, **NO REFUND ON PAYMENT – 100 % PAYMENT REQUESTED.**
